ADVERTISING POLICY & CONTENT GUIDELINES

To ensure all advertising displayed on CityOfBaldKnob.com and the City of Bald Knob's official social media pages maintains a professional, family-friendly, and community-centered standard, all participants must adhere to the following policy and content guidelines.

These regulations apply to all advertisements—both provided by the advertisee or by Blayed Media on the advertisee's behalf.

1. General Advertising Standards

All advertisements must reflect positively on the City of Bald Knob and its community values. Ads should be appropriate for all audiences and comply with applicable local, state, and federal laws.

Advertisements may be rejected, removed, or modified at the City's discretion if they violate these guidelines or are deemed inconsistent with the City's standards of public presentation.

2. Prohibited Content

The following content is strictly prohibited in all advertisements:

- Obscene, explicit, or sexually suggestive material of any kind.
- References to or imagery involving alcohol, tobacco, vaping, or drugs, including paraphernalia.
- Violent, profane, or threatening language or imagery.s.
- False, misleading, or deceptive claims about products, services, or affiliations.
- Defamatory or discriminatory content targeting individuals or groups based on race, gender, religion, sexual orientation, nationality, or other protected classifications.
- Third-party copyrighted materials or logos used without permission.
- References to illegal activity or any material that promotes unsafe or unlawful behavior.

3. Design & Format Requirements

To maintain consistency and visual quality across the City's platforms:

- All ads must fit the City's pre-defined size and placement templates (dependent on the plan chosen and paid for).
- Submitted ads must be in .PNG or .JPG format and be a minimum resolution of 150 DPI.
- Text must remain legible on all screen sizes; the City reserves the right to request revisions for readability.

If a business does not have an ad that meets these standards, Blayed Media can design one for a discounted rate of \$20, ensuring compliance with City guidelines.

4. Review, Duration & Revisions

- All ad submissions are reviewed prior to publication.
- Ads publish on Mondays following approval, and start a duration based on the selected plan.
- Modifications to approved ads must be resubmitted for review prior to publication by 3 business days. Requested modifications after approval may delay publication. Post publication, modifications may not occur.

5. Accountability

By submitting advertising forms and payment, the advertiser acknowledges they have read, understood, and agree to follow these regulations. Advertisers also acknowledge that the City of Bald Knob and Blayed Media are not responsible for ad performance, audience engagement, or resulting business activity.
